RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK, AND INDEMNITY
AGREEMENT

Please read and be certain you understand the implications of signing.

Express Assumption of Risk Associated with a Direct Encounter with Full Contact Haunted House Events:
Terror On Route 66, Sullivan, MO.

I understand that due to the Full Contact Experience, social distancing may not be possible. I understand there is extra risk this season and assume all risks associated with attending **Full Contact Experience 2026**.

I, _____, do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with a direct encounter with the haunted house to which I am about to engage, including but not limited to:

1. Any climbing, touching, grabbing, scratching, pushing, shoving, or biting that may occur during this experience.
2. Any incident caused by activities consistent with an extreme haunted house, or weather-related incidents, including lightning, variances, and extremes of wind, weather, and temperature; or any acts of "God."
3. Any incident resulting from loss of sense of balance, falling, slipping, tripping, twisting of extremities, limited physical condition, inability to follow directions, or lack of general common sense when attending a haunted attraction.
4. Equipment failure or handler error.
5. Pre-existing injuries or illnesses, including fatigue, chills, and/or reaction time and increased risk of an accident.
6. Any and all injury or incident resulting from failure to follow the strict instructions and direction from any employee of **Terror On Route 66**.

ENTER AT YOUR OWN RISK!

I understand that the above-described risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Furthermore, **Terror On Route 66's** employees seek safety, but they are not infallible. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

I understand that I will most likely experience the following: **TOUCHING, GRABBING, BUMPING, SPRAYING WITH WATER, TOUCHING GROSS AND UNCLEAN ITEMS, EXTREME SCARES, AIR BLASTS, ANIMATIONS, STROBE LIGHTS, SPECIAL SCARE EFFECTS, WET CONDITIONS, DANGEROUS EXPERIENCES, FOG AND FOG EFFECTS, MIRRORS AND GLASS, OUTDOOR HAZARDS, AND DIRECT INTERACTION WITH ACTORS. I ALSO UNDERSTAND THAT ALL PERSONAL PROPERTY BROUGHT INTO THE EXPERIENCE AREA HAS THE POTENTIAL TO BE BROKEN, STOLEN, OR DAMAGED DURING THE EXPERIENCE. ALL ITEMS OF VALUE ARE RECOMMENDED NOT TO ENTER THE EXPERIENCE AREA.**

I specifically acknowledge that I am **at least 18 years of age** and that I have read, understand, and agree to abide by all haunted house instructions at all times. I certify that I am physically and mentally able to participate in the haunted house activities to which I am about to engage.

I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition that I might aggravate or cause myself.

I specifically waive any defense insofar as this contract is concerned that may arise as a result of any law and/or regulation or policy that may impact its enforceability.

In consideration of being allowed to participate in the above-described activities, as well as the use of any of the facilities and the use of the equipment of the below-listed releasees, I hereby agree as follows:

1. To waive and release any and all claims based upon negligence, active or passive, with the exception of intentional or willful misconduct that I may have in the future against **Terror On Route 66**.
2. To release **Terror On Route 66**, its officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise, with the exception of intentional or willful negligence. By executing this document, I agree to hold **Terror On Route 66** harmless and indemnify them in conjunction with any injury, property damage, or loss of life that may occur as a result of engaging in the above activities.

By entering into this Agreement, I am not relying on any oral or written representation or statements made by the releasees, other than what is set forth in this Agreement.

I hereby declare that I am of legal age and am competent to sign this Agreement.

I have read this Agreement, understand it, and I agree to be bound by it.
